



GENERAL SYLLABUS FOR EDUCATION AT THIRD-CYCLE LEVEL IN MUSIC EDUCATION

1 Subject Area

Music education as science studies all forms of music teaching and learning including the frameworks, prerequisites, traditions and conditions that influence the situations where music constitutes the content of the various learning processes. Problems are thus dealt with in contexts where music is or has been an element in upbringing, education, teaching or any other influence in some cultural and societal situation. Music education as a field of research is interdisciplinary by nature and uses theories and methods from for example education, psychology, sociology, philosophy and musicology in order to understand and explain phenomena in music education.

2 Programme curriculum

Education at third-cycle level in Music Education that concludes with a Degree of Licentiate comprises a total of two years' full time study (120 credits) and consists of a study programme that gives 45-60 credits and a licentiate thesis that gives 60-75 credits.

Education at third-cycle level in Music Education that concludes with a Degree of Doctor comprises a total of four years' full time study (240 credits) and consists of a study programme that gives 90-120 credits and a doctoral thesis that gives 120-150 credits.

During the first year the doctoral student is expected to participate in a national or Nordic conference and present a poster.

During the second year the doctoral student is expected to participate in a national or Nordic conference and present a paper individually or together with supervisor or another senior researcher.

During the third year the doctoral student is expected to participate in an international conference and present a poster or a paper together with supervisor or another senior researcher.

During the fourth year the doctoral student is expected to individually present a paper at an international conference.

A mandatory part of the education at third circle level is to participate in research seminars at the institution and present own as well as give oral and written comments upon other's texts.

To guarantee that the doctoral student reaches expected learning outcomes a number of courses at the third circle level are defined as mandatory. See 4.1 below.

An individual study plan is drawn up for every third-cycle student (according to a fixed model) where the study programme is specified in detail. The individual study plan is followed up at least twice a year by the doctoral student and his/her supervisor and is approved by the Head of Department at least once a year, as delegated by the Vice-Chancellor.

3 Eligibility and selection

3.1 General eligibility requirements

An individual fulfils the general eligibility requirements for the third-cycle educational programme when he or she 1) has completed a second-cycle degree, 2) has completed higher education courses worth at least 240 credits, of which at least 60 are for second-cycle courses, or 3) in some other manner, in this country or abroad, has acquired the equivalent qualifications. The faculty board may permit an exemption from the requirement of basic eligibility in the case of an individual applicant, if there are special grounds Chapter 7, Section 39 of the Higher Education Ordinance (2010:1064). Also refer to the local guidelines laid down in the Admission Rules for Third-cycle Education at Luleå University of Technology.

3.2 Specific eligibility requirements

Main subject Music education 80 credits /main field of study Music education/equivalent subject 60 ECTS, second cycle.

Good command of oral and written communication in Swedish and English.

3.3 Selection

Selection from among applicants meeting the requirements shall be made with reference to their ability to benefit from the education. The mere fact that an applicant is deemed able to receive credit towards the education for previous education or working activities may not alone give the applicant precedence over other applicants in the selection process, Chapter 7, Section 41 of the Higher Education Ordinance (2010:1064). Also refer to local guidelines laid down in the Admission Rules for Third-cycle Education at Luleå University of Technology.

In the selection of third-cycle education in Music education the following applies to the selection criteria:

- Earlier academic works' quality
- Formulated research plan
- Professional experience.

4 Examinations included in the education

The education consists of courses and an academic thesis. Examinations included in third-cycle programmes are graded Pass or Fail. Course and licentiate thesis grades are decided by specially appointed teachers (examiners). Doctoral thesis grades are decided by a specially appointed grading committee.

4.1 Courses

Mandatory courses:

- Music education (15 credits for doctoral exam of which 7.5 credits for licentiate

- exam/first part of the education)
- Research methods (15 credits for doctoral exam of which 7.5 credits for licentiate exam/first part of the education)
- Science theory
- Academic writing
- Research ethics

Goal attainment is tested by means of the form of examination specified in the syllabus.

4.1.1 Recognition of prior studies

As specified in the local guidelines laid down in the Admission Rules for Third-cycle Education at Luleå University of Technology.

4.2 Academic thesis

An academic project in the form of a dissertation/thesis in music education shall be presented as a homogenous, cohesive academic work (monograph) or a brief summary – comprehensive summary – of academic essays (composite thesis) that the third-cycle student has written alone or together with another person or persons.

Thesis manuscripts shall be presented at one or more research seminars or be subjected to equivalent review through the agency of the department.

The licentiate thesis is defended orally at a public licentiate seminar and is graded Pass or Fail. When the thesis is graded both the content of the thesis and the defence of the thesis are taken into consideration. The grade of a licentiate thesis is decided by an examiner appointed by the Head of Department.

The doctoral thesis is defended orally at a public disputation and is graded Pass or Fail. When the thesis is graded, both the content of the thesis and the defence of the thesis are taken into consideration. Grades for a doctoral thesis should be decided by a grading committee that is appointed for each thesis.

5 Degree

In Music education, a third-cycle student who has been admitted to a Degree of Doctor has the possibility to take a Degree of Licentiate after completing one part comprising at least 120 credits of a study programme intended to conclude with the award of a Degree of Doctor.

5.1 Degree objectives

As specified in the Qualifications Ordinance (Higher Education Ordinance, Annex 2 – Degree Ordinance). See also the Annex below.

5.2 Degree title

A third-cycle student who takes a Degree of Licentiate in Music education receives the degree title of Licentiate of Philosophy.

A third-cycle student who takes a Degree of doctor in Music education normally receives the degree title of Doctor of Philosophy.

Requests for other degree titles are made according to established guidelines.

6 Entry into effect and interim regulations

The previous general syllabus will cease to apply for third-cycle students who are admitted to education at third-cycle level after 1 July 2007 and 16 January 2013. Third-cycle students admitted before this date may choose to either follow the previous syllabus or transfer to the syllabus that applies for third-cycle students admitted after 16 January 2013.

THIRD-CYCLE QUALIFICATIONS

General qualifications

Degree of Licentiate [Licentiatexamen]

Scope

A Degree of Licentiate is awarded

either after a third-cycle student has completed a study programme of at least 120 credits in a subject in which third-cycle teaching is offered,

or after a third-cycle student has completed one part comprising at least 120 credits of a study programme intended to conclude with the award of a Degree of Doctor, if a higher education institution decides that a licentiate of this kind may be awarded at the institution.

Outcomes

Knowledge and understanding

For a Degree of Licentiate the third-cycle student shall:

- demonstrate knowledge and understanding in the field of research including current specialist knowledge in a limited area of this field as well as specialised knowledge of research methodology in general and the methods of the specific field of research in particular.

Competence and skills

For a Degree of Licentiate the third-cycle student shall:

- demonstrate the skills to identify and formulate issues with scholarly precision critically, autonomously and creatively, and to plan and use appropriate methods to undertake a limited piece of research and other qualified tasks within predetermined time frames in order to contribute to the formation of knowledge as well as to evaluate this work



- demonstrate the skills in both national and international contexts to present and discuss research and research findings in speech and writing and in dialogue with the academic community and society in general, and
- demonstrate the skills required to participate autonomously in research and development work and to work autonomously in some other qualified capacity.

Judgement and approach

For a Degree of Licentiate the third-cycle student shall:

- demonstrate the skills to make assessments of ethical aspects of his or her own research
- demonstrate insight into the possibilities and limitations of research, its role in society and the responsibility of the individual for how it is used, and
- demonstrate the skills to identify the personal need for further knowledge and take responsibility for his or her ongoing learning.

Thesis

For a Degree of Licentiate the third-cycle student shall have been awarded a Pass grade for a research thesis of at least 60 credits.

Miscellaneous

Specific requirements determined by each higher education institution itself within the parameters of the requirements laid down in this qualification descriptor shall also apply for a Degree of Licentiate with a defined specialisation.

Degree of doctor

Scope

A Degree of Doctor is awarded after the third-cycle student has completed a study programme of at least 240 credits in a subject in which third-cycle teaching is offered.

Outcomes

Knowledge and understanding

For the Degree of doctor the third-cycle student shall:

- demonstrate broad knowledge and systematic understanding of the research field as well as advanced and up-to-date specialised knowledge in a limited area of this field, and



- demonstrate familiarity with research methodology in general and the methods of the specific field of research in particular.
- demonstrate the capacity for scholarly analysis and synthesis as well as review and assess new and complex phenomena, issues and situations autonomously and critically
- demonstrate the skills to identify and formulate issues with scholarly precision critically, autonomously and creatively, and to plan and use appropriate methods to undertake research and other advanced tasks within predetermined time frames and to review and evaluate such work
- demonstrate through a dissertation the skills to make a significant contribution to the formation of knowledge through his or her own research
- demonstrate the skills in both national and international contexts to present and discuss research and research findings authoritatively in speech and writing and in dialogue with the academic community and society in general
- demonstrate the skills to identify the need for further knowledge and
- demonstrate the capacity to contribute to social development and support the learning of others both through research and education and in some other qualified professional capacity.

Judgement and approach

For the Degree of Doctor the third-cycle student shall:

- demonstrate intellectual autonomy and disciplinary rectitude as well as the ability to make assessments of research ethics, and
- demonstrate specialised insight into the possibilities and limitations of research, its role in society and the responsibility of the individual for how it is used.

Research thesis (doctoral thesis)

For the Degree of Doctor the third-cycle student shall have been awarded a Pass grade for a research thesis (doctoral thesis) of at least 120 credits.

Miscellaneous

Specific requirements determined by each higher education institution itself within the parameters of the requirements laid down in this qualification descriptor shall also apply for a Degree of Doctor with a defined specialisation. Ordinance (2008:132)
