

Outgoing students are invited to pre-departure meetings, kick off seminars, and given the possibility to apply to a wide range of language courses. Incoming students are invited to, Orientation week, welcome meetings, and academic workshops.

The International Office is available for individual meetings for incoming students and students interested going on exchange. Incoming students have access to Academic advisors for course related issues at each department.

LURC (Luleå University Reception Committee) organizes a buddy programme and the Arrival week with activities and information meetings for international students. Throughout the year, activities and trips are arranged.

The International Office offer guidance to outgoing teachers and administrative staff. Incoming participants are taken care of either by the concerned department or by the International office.

Evaluations for in- and outgoing exchanges for students and teachers/staff are done regularly through surveys, reports and questionnaires.

Support and guidance to departments, applying for funding of international projects is offered by the International Office and the Grants Office. The support includes all steps in the application process.

The Erasmus+ programme is open for all students and staff at the University.

All Swedish HEI are by law obliged to follow the Discrimination Act. The University has to work to prevent discrimination and promote equal rights and opportunities, regardless of gender, identity or expression, ethnic affiliation, religion or other beliefs, disability sexual orientation or age.

The University has got a policy and action plan for providing equal conditions for students and employees where organization and responsibility for issues concerning equal treatment are stated. At the University no student nor staff shall be discriminated against or otherwise mistreated because of: sex, gender identity or expression, religion or other belief, ethnicity, disabilities, sexual orientation, age, lack of availability.

Support for student with disabilities is a well-established at the University. Appointed staff is working to provide students with sufficient support and arrangements in order to compensate for functional limitations in the student's study situation

The Gender mainstreaming plan has to include development needs, goals and activities that the university intends to introduce and implement. In addition, the plan must describe how gender equality will be embedded in the university's mainstream activities. At the University there are regularly activities arranged for attracting women to technical education programmes. The University is part of Include, a national network with inclusion and diversity in higher education as their main goals.

Social diversity of the student body is important and the University have activities that support participation of disadvantaged groups. For many years the University has been involved in projects to present possibilities for higher education to immigrants. Projects in cooperation with adult education, upper secondary schools, authorities connected to the labour market and the industry are also carried out to ease the entrance to the labour market.

Distance learning technologies and distance courses/programmes are important to include a more diverse student group. Through digitization and new technology, we promote innovative teaching and learning environments as well as efficient and accessible services.

Blended mobility will make it possible to include a wider student group which will gain international experiences through the combination of physical academic mobility, virtual mobility and blended learning.

Digitalisation, or the use of new technology, will pervade the entire university. In the field of education, sensors and computer-based services may provide a better understanding of the students' learning processes, of what characterizes a distinguished university teacher and of how to optimise time devoted to education.

In our strategy it is stated that the University through digitalisation and technological leaps, will create prerequisites to meet future needs in education, research and administrative processes.

The University has participated in workshops and meetings organised by our National Agency in order to prepare us for the digitalisation of the Erasmus programme. An internal plan for the implementation of the European Card Initiative to students and staff will be established.

The Erasmus+ app has already been introduced to our outgoing students.

The University will implement the European Card Initiative according to provided timeline:

Autumn 2020- the process to start register institutional agreements with our partner universities on-line

2021- manage On-line Learning agreements for students

2022- send and receive student nominations and acceptances.

2023- exchange transcripts of records related to student mobility

The University is using MoveOn to handle international exchanges and MoveOn will be connected to the European card initiative.

The University will follow the development of the European Student Card Initiative closely to make sure we are in phase with the implementation of available features.

Please explain how your institutions will implement and promote environmentally friendly practices in the context of the Erasmus+ programme.

According to the Higher Education Act, all HEI in Sweden must promote sustainable development. Higher education institutions have a central role in efforts to fight climate change. The University has an important task to contribute through teaching and research, but we also need to reduce the impact of our own operations.

The University is part of the Climate Framework, a national network where 37 Swedish universities and colleges have created a combined climate framework as the basis for individual climate strategies. The Framework has been initiated by the HEIs in Sweden with the ambition of clearly contributing to climate change adaption in line with society's national and international commitments. By 2030, all the HEI signatories of this Climate Framework will have implemented measures in order to be in line with the 1.5°C target. The Climate Framework also address that all partners contribute to achieving the 17 global sustainable development goals of Agenda 2030.

The HEIs that have signed this framework consider the climate to be a crucial and prioritised issue. As part of this Climate Framework our University has undertaken to do the following:

 We will through education, research and external engagement help society as a whole to achieve set targets.

- We will work to reduce our own climate impact in line with society's commitment as expressed in national and international agreements.
- We will, based on our HEI-specific conditions, set up far-reaching targets for climate-related work and also allocate resources so that we can achieve these targets and conduct follow ups.
- We will clearly communicate our climate-related work in order to inspire and spread knowledge to other organisations and members of society.

The Framework includes guidelines for travelling, waste management, food and food services etc.

During 2020 the University is going to put forward a revised Policy for sustainable development. This policy will be decided by the Vice-Chancellor in the autumn.

Our environmental approach includes:

- The University develops the attractive sustainable society through research and education. Many of our research subjects relate to different aspects of sustainability, like natural resources management, sustainable urban development, waste management and recycling. Sustainability is also a key issue in our work to develop our learning environment.
- Sustainability and environmental issues are components in course and programme syllabus to provide knowledge and ability to our students reaching the 2030 Agenda and the global sustainable development goals.
- In the Travel Policy it is stated that all business travel should be made as safe and costefficient and environmental friendly as possible.
- Seminars, workshops, meetings will by using digital technique will be in line with our main vision. Through digitization and new technology, we promote innovative teaching and learning environments as well as efficient and accessible services.

To encourage environmental friendly exchanges, the University will introduce a top up grant for students and staff choosing the most environmental transportation for the travel.

Student organisations at the university are working in various projects, related to environment and sustainability.

Luleå Reception Committee (LURC) part of the ESN network, organizes several different types of activities and events for international students at LTU. LURC always introduces recycling possibilities for new students.

With an inclusive culture formed by courage, openness and trust, we create development and innovation.

In the region, LTU has a key role for regional development that links the local community with education, research and business. Cooperation locally, regional and international is essential to meet challenges related to education, labour market, research as well as social and cultural differences.

A welcoming and inclusive approach shall characterise each and every part of the University. This includes building strong and long-term relationships between students, staff and stakeholders in society, nationally and internationally. Long-term relationships are built between students in different disciplinary domains, between students and teachers, and between students and researchers.

The Student Unions aim to create an inclusive and friendly environment for all students. They encourage all student groups to participate in their work, project and activities.

Our Career Service cooperate with the industry in different projects, preparing the students for the labour market. International students have the possibility to join and participate in projects getting acquainted with the industry and community in the region.

At the University there are many different student organisations within many fields of interest, open for all students to join.

LURC (Luleå University Reception Committee) is part of the ESN-network. LURC is a student organisation with the aim to greet and host our international students. Both Swedish and international students are working for LURC, arranging activities and trips throughout the year.

Among many things, LURC organises buddy programmes for our incoming students. LTU-students have the possibility to join an international environment at home, and the activities give our international student an introduction to Sweden and our culture. Language cafes open to all students and staff are held once a week. LURC also arranges study visits to companies, and cultural heritage in the region.

HR arranges "Meet and Greet" regularly. A possibility for our international staff and PhD students together with their families, to take part of Swedish culture and learn about our society.

In the Higher Education Ordinance (1993:100) possibility of obtaining transfer of credits for previous studies and equivalent knowledge and skills acquired in professional context is regulated.

At the University there is a local Policy document which is well established, clear, transparent and with efficient routines.

At all HEIs in Sweden, the student always has to apply for recognition of studies which enables students to choose which courses they want to recognize in their degree.

On the web site, information and the process on how to apply for transfer of credits is well described. We support the students in finding courses at the receiving university. To secure the possibility to get recognition of the courses into their programmes, students get their Learning agreements approved by their programme coordinators. When the students return from their exchange, they receive information on how to apply for transferring the credits.

Academic recognition for blended mobility will be handled the same way and follow the same rules as a traditional physical mobility abroad.

Students preferably choose their free elective courses during their exchange period which enhances the chances of recognition at the home institution.

Learning agreements for traineeships, also have to be approved by the departments before departure. A routine to include the Erasmus training placement in the Degree Certificate is established.

Incoming students have access to our course catalogue well in advance before their arrival. The Learning agreements are handled and signed by staff at the International office. The incoming students apply for their Transcript of Records on-line.

One of the objectives that is part of the main strategy "Internationalisation" is to create good opportunities for international mobility for students and staff. Teacher/Staff mobility is the basis of sustainable student mobility, it is a key to encourage and perform successful student exchanges.

Another aspect of an increase of teachers/staff with international experiences, is "Internationalisation at home" in terms of international learning environments for students and staff not participating in physical exchanges.

International experiences is also essential for pedagogical and scientific progress as well as professional and personal development.

How do we support, promote and recognise mobility?

The most important tool is our website and social media. On the web site and in social media we have platforms for communication with staff and teachers. We use them to publish information about open calls, about different mobility programs and we also highlight stories from students, staff and teachers that have taking part of an exchange program.

The possibilities for mobility is also communicated to our departments by other communication channels, through information meetings and seminars. Previous experiences from teachers and staff are used as an inspiration for marketing exchange possibilities within Erasmus. Teachers are encouraged to inspire their colleagues and to give a talk about their experiences when they return.

Experience from staff exchange can be included in the teaching/work portfolio and recognised as professional development for the individual.
